The problem of builders working very early in the morning on weekends and very late at night was discussed. The building committee will explore possible solutions.

Mid-Central Pest Control has serviced the building at a cost of \$45. For a cost of \$10 monthly, they will service the building whenever it is needed.

Mr. Krueger moved to hire Dan Kedas for part time road work at as salary of \$3.50 per hour, subject to interview by Mr. Krueger. Second by Mr. Morency, roll call: Ciuca, Krueger, Morency, Mountjoy, Myers, Roberts, aye. O nays, O absent.

Mr. Mountjoy moved to authorize Mr. Roberts to purchase a new phone answering device, second by Mr. Krueger. Roll call: Ciuca, Krueger, Morency, Mountjoy, Roberts, Myers, aye; O nays; O absent.

Question: What shall be the policy for the determination of sewer hook-up for newly platted subdivisions?

The committee recommends that the following policy apply to newly platted subdivisions or portions thereof from now until six months before the "Valley" sewer system is operational:

- 1. Development will not be contingent on the availability of sewer systems if the land without artificial improvements meets present septic field requirements.
- sewer systems on subdivision lots that do not meet the above septic field requirements unless the following three conditions are met:

 A. Soil conditions necessary for approved septic systems can be artificially created.
 - B. At the time of development, approved facilities are installed for the future connection of homes on such lots to the "Valley" sewer system.
 - c. Agreements are signed and recorded that all residences on such lots will be connected to the "Valley" sewer system when it becomes operational.

Approximately six (6) months before the "Valley" sewer system becomes operational a review of this policy should be made to determine if changes are required.
