Mr. Roberts moved to approve the Quadcom agreement dated May 25, 1978, second by Mr. Myers, motion carried by voice vote.

Mr. Krueger authorized the President and Clerk to sign the second grant application for Quadcom, second by Mr. Ciuca, motion carried by voice vote.
