Village Board Minutes, April 16, 1979, 7:50 PM

The regular meeting of the Corporate Authorities of the Village of Sleepy Hollow was called to order by President Carol Schoengart on April 16, 1979 at 7:50 PM. Roll was called and answered as follows: Morency, Mountjoy, Peterson, Roberts, Wilkison, Schoengart, present. Also present were Clerk Pofahl, Chief Bradley, Attorney Knickerbocker, Engineer Anderson, Plan Commission Hohner.

Treasuere Ken Nolte passed away on April 9, 1979; Mrs. Schoengart asked everyone to observe a moment of silence in his honor.

Mrs. Peterson moved to accept the minutes as corrected, the cash balance total should be \$97,036.06. Second by Mr. Wilkison, motion carried by voice vote.

Mr. and Mrs. Mountjoy have temporarily taken over the duties of Trueaurer. The monthly report has been prepared, a more complete report will be ready for the next meeting which will be a special meeting on April 23 at 7:30 PM.

Mr. Mountjoy moved to accept the minutes of the Revenue Sharing Hearing, second by Mr. Morency, motion carried by voice vote.

Ray Miller will attend a CATS meeting on Friday to present our petition for Intermittant Resurfacing Funds.

Mr. Morency moved to pass Ordinance #11-9-A3-3 being "AN ORDINANCE AMENDING ORDINANCES NO. 11-9-3, 11-9-A-2, 11-9-A2-3, BY PROVIDING FOR NEW REGULATIONS FOR THE LICENSING OF MOTOR VEHICLES IN THE VILLAGE OF SLEEPY HOLLOW", second by Mr. Roberts, roll call: Morency, Mountjoy, Peterson, Roberts, Wilkison, aye; O nays; O absent.

Regarding the bonfire for Halloween, there will be no dumping of refuse for the bonfire until October 1, 1979.

Ray Miller representing the Service Club presented plans for the pavillion. Mrs. Peterson moved to commend Ray for his work and approve the concept of the plan. Details of location and exterior will be discussed by the Parks Committee and final plans presented to the Village Board. Second by Mr. Morency, motion carried by voice vote.

Mr. Hankla and Mr. Sammis must reach an amicable decision on the placement of Hankla's basketball backboard, or Hankla must go before the Zoning Board of Appeals and ask for a variance.

A report of the Zoning Board of Appeals was read, they will meet on May 5, 1979 at 9:30 AM to consider Ms. VanDerMeydens request for a variance. The April 7 meeting was adjourned to May 5 due to a lack of information.

The lease for the Fire Department land was brought up. Mr. Roberts moved to pass Resolution #76 authorizing the President and Clerk to execute a 99 year lease of land with the Rutland Dundee Townships Fire Protection District. Second by Mrs. Peterson, roll call:

Mr. Morency moved to pass Ordinance 11-14-1 being "AN ORDINANCE AMENDING CHAPTER 11, MISDEMEANORS AND OTHER OFFENSES, OF THE MUNICIPAL CODE OF THE VILLAGE OF SLEEPY HOLLOW, BY ADDING THERETO AN OFFENSE ENTITLED DAMAGE TO PROPERTY", second by Mrs. Peterson, roll call: Morency, Mountjoy, Peterson, Roberts, Wilkison, aye; O nays, O absent.

Mr. Morency moved to pass Ordinance 11-15-1 being "AN ORDINANCE ESTABLISHING PARENTAL RESPONSIBILITY FOR CERTAIN ORDINANCE VIOLATIONS WITHIN THE VILLAGE OF SLEEPY HOLLOW", second by Mr. Mountjoy, roll call Morency, Mountjoy, Peterson, Roberts, Wilkison, aye; O nays, O absent. This Ordinance repeals Ord. 11-13-1.

Mr. Roberts moved to pass Ordinance #10-5-A5-1, being "AN ORDINANCE AMENDING CHAPTER 10, BUILDING, OF THE MUNICIAPAL CODE OF THE VILLAGE OF SLEEPY HOLLOW, KANE COUNTY, ILLINOIS", this changes the fees for building permits. Second by Mr. Morency, roll call: Moreny, Mountjoy, Peterson, Roberts, Wilkison, aye; O nays; O absent.

Mrs. Peterson presented ideas for equipment for the tot lot in Sabatino Park, cost approximately \$1500.

Mr. Roberts moved to adjourn , second by Mr. Wilkison, motion carried by voice vote.

Meeting adjourned at 10:30 PM until April 23, 1979 at 7:30 PM for a recommend special meeting.
