Reconvened meeting of July 16, 1979, held July 30, 1979.

The reconvened meeting of July 16, 1979 was called to order on July 30, 1979 at 8:05 PM by President Carol Schoengart. Roll was called and answered as follows: Peterson, Roberts, Thomas, Zhe, Schoengart, present. Milz, Mountjoy, absent. Also present was Clerk Pofahl.

Mr. Al Treml of Sharon Dr. asked permission to erect a tent for a party on Aug. 2 on the Cul de sac of Sharon Dr. Mr. Thomas moved to grant such permission, second by Mrs. Peterson, motion carried by voice vote.

The Appropriations Ordinance was introduced. Mrs. Peterson moved to pass Ord. 19-23-6, being "AN ORDINANCE MAKING APPROPRIATION FOR CORPORATE PURPOSES FOR THE FISCAL YEAR BEGINNING MAY 1, 1979, AND ENDING APRIL 30, 1980, FOR THE VILLAGE OF SLEEPY HOLLOW, KANE COUNTY, ILLINOIS." second by Mr. Thomas, roll call: Peterson, Roberts, Thomas, Zhe, Schoengart, aye. O nays, 2 absent.

Mary Sjogren has been hired as secretary beginning July 10, 1979. Salary to be \$3,50 per hour for the month of July, \$3.75 beginning Aug. 1. Sharon Montalbano has been hired to clean the Village Hall at a salary of \$4 per hour. Mrs. Zhe moved to hire Mary and Sharon at the stipulated salaries, second by Mrs. Peterson, roll call: Petrerson, Roberts, Thomas, Zhe, Schoengart, aye. o nays, 2 absent.

Adjourn to executive session, 8:25 PM.

Reconvene, 9:20, roll call: Peterson, Roberts, Thomas, Zhe, Schoengart, present. Milz, Mountjoy, absent.

Mr. Roberts moved to accept Elgin-Waynes proposal for trash removal for a three year period beginning September 1, 1979, schedule to be as follows: \$5 per month Sept. 1, 1979-Augs. 31, 1980; \$5.75, Sept. 1, 1980 to Aug. 31, 1981; \$6.50, Sept. 1, 1981-Aug. 31, 1982. \$15 per month for back door pickup. \$5 per cubic yard for extra materials. A contract will be prepared. Mrs. Zhe seconded, roll call: Peterson, Roberts, Thomas, Zhe, Schoengart aye. O nays, 2 absent.

Mr. Thomas moved to self-insure maternity benefits for mother and child up to \$1500 for all full-time employees and their legal spouse, beginning August 1, 1979, Mrs. Zhe seconded, roll call: Peterson, Roberts, Thomas, Zhe, Schoengart, aye. O nays, 2 absent.

Mr. Roberts moved to adjourn, second by Mrs. Peterson, meeting adjourned 9:45 PM
