Village Board Minutes, August 6, 1979.

The regular meeting of the Sleepy Hollow Corporate Authorities was called to order on August 6, 1979 at 7:35 PM by President Carol Schoengart. Roll was called and answered as follows: Milz, Mountjoy, Peterson, Roberts, Thomas, Zhe, Schoengart. Also present were Clerk Pofahl, Treasurer Scott, Chief Bradley, Plan Commission Hohner.

Mrs. Zhe moved to approve the minutes of the July 16 and 30 meetings second by Mrs. Reterson, motion carried by voice vote. Mrs. Zhe moved to approve the minutes of the July 30 Appropriations Ordinance hearing, second by Mrs. Peterson, motion carried by voice vote.

Treasurer's report: Cash receipts: \$3,281.02. Bills Payable: \$5,962.41. Cash balances: General funds, \$109,807.23; Revenue Sharing, \$3,944.86; MFT, \$32,760.47; Road Bond funds, \$27,658.99; Total: \$174,171.55.

Mr. Roberts moved to accept the Treasurer's report and pay the bills, second by Mr. Mountjoy, roll call: Milz, Mountjoy, Peterson, Roberts, Thomas, Zhe, aye. O nays, O absent.

Thursday, August 9, at 7:30 PM in the West Dundee Village Hall, there will be a public hearing concerning the road improvements planned for Routes #31 and #72.

Mr. Mountjoy moved to donate \$2,000 to DAIPC, second by Mrs. Zhe, roll call: Milz, Mountjoy, Peterson, Roberts, Thomas, Zhe, aye. O nays, O absent. Mr. Ranga Galiveti, asst. planner was present.

The August 20 meeting of the Village Board will be postponed until August 27, 1979 at 7:00 PM. Tax Levy Ordinance is on the agenda.

Plan Commission will meet on August 27, 1979 at 8:00 PM. Board members are requested to attend.

Ed Hoff of the Sleepy Hollow Service Club requested permission to stage a rock concert in the Pavillion at Sabatino Park on Aug. 11 from 2:00PM - 5:00 PM. Mr. Thomas moved to allow the Service Club to organize the concert, second by Mrs. Peterson, roll call: Milz, Mountjoy, Thomas, Peterson, Zhe, aye, Roberts, abstain. Onays, O absent.

Mr. Hoff discussed the possibility of getting water to the pavillion.

Mr. Milz moved to send a letter to the States Attorney requesting his office to investigate the bid practices of disposal companies. second by Mr. Thomas, motion carried by voice vote, 3 abstentions.

Mrs. Zhe moved to allow the Dundee Township Park District to complete work on the seccer field in Sabatino Park, cost to the

Mrs. Zhe moved to authorize the Building Committee Chairman to go out for bids on general maintainance and repairs on the Village Hall. Details of the work to be worked out by Mr. Miller, Mr. Roberts and Chief Bradley. second by Mr. Roberts, motion carried by voice vote.
