Village Board Minutes, October 1, 1979

The regular meeting of the ^Sleepy Hollow Corporate Authorities was called to order on October 1, 1979 by President Schoengart. Roll was called and answered as follows: Milz, Mountjoy, Peterson, Roberts, Zhe, present, Thomas absent. Also present were Treasurer Scott, Clerk Pofahl, Chief Bradley, Attorney Knickerbocker, Engineer Andersen, Plan Commission Hohner, ZBA Ward.

Mrs.nZhe moved to accept the minutes of the previous meeting, second by Mr. Milz, motion carried by voice vote.

Treasurer's report: Cash balances--General Funds, \$126,489.71; Revenue Sharing Funds, \$3,944.86; MFT Funds, \$38,885.14; Road Bond Funds, \$9,795.55. Bills payable, \$5,116.02; Cash receipts: \$84.157,54.

Mrs. Peterson moved to accept the Treasurer's report and pay the bills, second by Mr. Mountjoy, roll call: Milz, Mountjoy, Peterson Roberts, Zhe aye. O mays 1 absent.

Mr. Roberts moved to rehire Sharon Montalbano as Secretary at \$4.00 as of August 22, she will work Wednesday and Friday; also to raise the salary of Mary Sjogren who works Tuesday and Thursday to \$4.00 per hour as of November 1, 1979. Mr. Roberts moved to authorize payment of 3534.09 for 1978 real estate taxes on 11 lots, this is the second year. second by Mr. Milz, roll call: Milz, Mountjoy, Peterson, Roberts, Zhe, aye. 0 nays, 1 absent.

Mr. Ray Miller gave a progress report on the repairs to the Hall: carpentry 80% done, sandblasting finished, roofer coming Wednesday, painter Mon. Oct. 8. Sandblasting cost reduced from \$4200 to \$2200. Mr. Roberts moved to pay Leonard and Sons Building Service, Inc. \$2200 for sandblasting, second by Mrs. Peterson, roll call: Milz, Mountjoy, Peterson, Roberts, Zhe, aye. O nays, 1 absent.

new gutters will be installed, new gas pipe from the road to the meter will be installed. Mr. Miller asked permission to tear down the old white fence and replace it with a three-rail rustic fence. Mr. M untjoy moved to authorize expenditure of \$100 to replace the fence, second by Mr. Roberts, motion carried by voice vote.

Mr. Roberts reported that the developer of Walnut Hill would like to put the final course of asphalt on the roads this Fall. Mrs. Peterson moved to send a letter to the developer requesting that he adhere to the original agreement as the soil would cause the road to settle out this winter , also heavy building eauipment would damage the road. second by Mrs. Zhe, motion carried by voice vote.

Plan Commission Chairman Hohner requested an executive session to discuss property acquisition.

A building permit has been issued for a new house on Holly Ct. Unit 13, lot 41.

Mr. Mountjoy moved to pay Curran Contracting \$\fit{g}\$ 33,506 for the work done on the roads this summer. second by Mr. Roberts, roll call: Milz, Mountjoy, Peterson, Roberts, Zhe, aye 0 nays, 1 absent.

Mr. Mountjoy moved to authorize the attorney to prepare a Resolution authorizing the President and Clerk to sign an agreement, which he will also prepare, concerning the purchase of the Sleepy Hollow Water Co.k according to a report prepared and presented by Gary Hohner on October 1, 1979. Such report is on file in the Clerk's office. Second by Mr. Roberts, motion carried by voice vote.

Mr. Milz authorized the attorney to resoliciate for bids for a financial advisor in connection with the proposed purchase of the Water Go. second by Mr. Mountjoy, motion carried by voice vote.
