March 2, 1981.

The regular meeting of the Sleepy Hollow Corporate Authorities was called to order on March 2, 1981 at 7:35 PM in the Fire Station by President Peterson. Mr. Mountjoy moved to accept the minutes, second by Zhe, motion carried by voice vote.
