Village Board Minutes, September 6, 1983

The regular meeting of the Sleepy Hollow Corporate Authorities was called to order on September 6, 1983 at 7:55 PM by President Peterson. Roll call: Cook, Grisolia, Rabe, Peterson; Clerk Pofahl, Chief Bradley, Attorney Rick Erickson.

Correction to minutes -- the teen drinking issue was discussed. Mr. Grisolia moved to accept the minutes of the previous meeting, second by Cook, carried by voice.

The Carpentersville Jamboree will be held September 17-19. Tast of Dundee is September 9-11.

Martin Carmody has resigned from the Planning Commission. Mr. Grisolia moved to accept his resignation with regret, second by Cook, carried by voice. Richard Reedy, 884 Walnut will attend the next meeting (Sept. 26) of the Planning Commission as a prospective member.

Attorney Re: Walnut Hill, G. Knickerbocker will meet with representatives of the LaSalle National Bank and Attorney Les Sanford sometime prior to September 15.

Roads Geske Construction will finish the road work on Wednesday. Mr. Rabe moved to add the seal coating of Plum Court, Carol Crest Drive, and Jill Peak Drive to the work at a cost not to exceed \$4200, second by Grisolia, roll call: Cook. Grisolia, Rabe, Peterson aye. 3 absent.

Police Frank Calabrese would like to rejoin the Police Department. Don Stevens will be able to take the firearms course. Mr. Rabe moved to authorize Chief Bradley to re-hire Frank Calabrese as a part-time Patrolman, second by Grisolia, carried by voice.

The twenty-two applications for part-time Patrolman will be reviewed by the Police Committee within the next 10 days.

Mr. Thomas moved to pay bills for Water D, I & E of \$2057.07, second by Grisolia,

roll call: Cook, Grisolia, Rabe, Thomas, aye.

Mr. Rabe moved to postpone the decision on computer purchase/vehicle tax repeal until December 15 as more research is needed; new information on new products is being sought, second by Grisolia, roll call: Cook, Grisolia, Rabe, aye. Thomas no.
