Village Board Minutes February 6, 1984

The regular meeting of the Sleepy Hollow Corporate Authorities was called to order at 7:35 PM on February 6, 1984 by President Peterson. Roll call: present-Cook, Matthews at 7:36, Roberts, Treece, Peterson. Rabe at 8:00. Thomas absent. Also Clerk Pofahl, Chief Bradley, Attorney Knickerbocker.

Mr. Roberts moved to accept the minutes, second by Treece, carried by voice. Mrs.  $^{\text{Ma}}$ tthews arrived.

Mrs. Peterson has asked Walt Heffron to reconvene the Zoning Board. The cost of hiring a consultant for the Plan Commission will be investigated.

The DuKane Valley Council program on Feb. 16 is on the Utilities and Economic Development. Theresa and/or Bonnie to attend.

Chapter One Ordinance--draft--is finished, copies to George Knickerbocker and Board members.

Mr. Rabe arrived.

Mrs. Matthews will work on regulations/ordinance governing mechanical septic systems.

La Salle National Bank will discuss obligations re! Walnut Hill bills of conveyance, surety bonds, demolition of log cabin, with George Knickerbocker sometime the next month or two.

Bills payable: Mr. Treece moved to pay bills of \$22,355.06 from G&A funds, second by atthews, roll call: all present aye.

Mr. Cook moved to pay bills of \$2,203.66 from Water O&M fund, second by Matthews, roll call: all present aye.

A list of savings and investments has been given to Board members.

Water hook-up committee--John Rabe. The committee presented various suggestions which have been incorporated into a proposed ordinance which will be reviewed by the Attorney. An ordinance should be ready by the March 6 meeting.

Main points: owners to test annually and give results to Village

well owner will connect when major repair needed residents to pay \$6 month, will escrow to pay hook-up fee right to appeal

applies to owners whose property line is within 100 feet of a main

Quadcom. Mrs. Matthews moved to accept the proposed amendments to the Intergovernmental Agreement, second by Roberts, all voted no. Wording is ambiguous and contradictory. Mr. Treece will take recommended changes to next Quadcom meeting. Mrs. Matthews moved to approve the amendment to Section 10 of the Intergovernmental Agreement regarding funding, second by Rave, all aye.

Mr. Rabe moved to accept the Finance Committee report and approve the 1984-85 budget

for "uadcom, second by Roberts, all aye.

Bill Russel has gone to work for West Dundee, we will put an ad in the paper to replace him.

Water. Cost estimates for Sleepy Hollow School hook up should be coming in soon. Mrs. Matthews moved to spend up to \$5100 to repair the backhoe, second by Rabe, roll call: all present aye.

The proposed design for new tables for the meeting room has proved to be too expensive, Mr. Rabe will look into buying three tables and 10 chairs.

Mr. Treece moved to pay \$60 dues to the Illinois Police Association for the four full time policemen, second by Matthews, carried, all aye.

Mr. Rabe moved to adjourn, second by Cook, adjourn 10:15 pm.
