Mr. Thomas moved to accept the budget as amended for a total of \$493,000 of total expenditures, second by Imhof, Thomas amended that Revenue Sharing money be allocated to Police Dept., second by Shields, roll call: all present aye on amendment, all presenaye on main motion.

Mr. Treece moved to accept Arnold Ross' bid to buy two Realistic CB radios for a total of \$75, second by Thomas, carried by voice

Mr. Harris moved to pass Ordinance #7-17-A-1 rescinding the five ton per axle weight limit, second by Treece, roll call: all present aye. Ord. 701701 expires May 18.

Mr. Cook moved to write off the unpaid water bill for Gaslight Club (Chateau Louise) in this fiscal year, and send the rest of the unpaid accounts to a collection agency, second by Thomas, carried by voice.

Mr. Thomas moved to approve the Water Dept. budget, second by Cook, roll call: all present aye. Mr. Thomas moved to approve the Sewer Dept. budget, second by Shields, roll call: all present aye. Mr. Treece moved to approve a 5% increase in salaries of all full time Police Officers:
