MINUTES

JANUARY 19, 1987

The regular meeting of the Sleepy Hollow CORPORATE authorities was called to order on January 19, 1987 at 7:40PM. Present were President Peterson; Trustees Harris, Hoff, Shields and Thomas (arrived at 8:05); Clerk McKeown; Attorney Knickerbocker; Engineer Whiston; Planning Commission Wiedmeyer.

Harris moved with a second from Hoff to approve the December 15, 1986 minutes. CARRIED BY VOICE

PRESIDENT 1 CODFICATION meeting will be January 26 , 7:30PM 2.Rich Reedy has resigned from the PLANNING COMMISSION. George Smith and Barbara Ferguson would like to serve another 3 years. shields moved with a second from Hoff to approve the appointment of Smith and Ferguson for 3 years.CARRIED BY VOICE. Peterson announced the Commission needs another member.

- 3. CABLE TV will be increasing their rates as of March 1.
- 4. NIPC is providing a workshop on Floodplain Regulations February 25th.
- 5. We have been included in the Governor's Hi. Tech. "Golden Corridor" running from O'Hare to Elgin. We are being asked to pass a resolution of acceptance and to donate \$200.
- 6. School District has called concerning the Rainbow Creek/BUS STOP. Hoff will discuss this with Chief Bradley.
- 7. The Dukane Valley Council will meet Wednesday in Batavia to discuss tax reform.
- 8. We have received a letter from the <code>IMLRMA</code> noting the changes in coverage as of 12-31-86
- 9. NIPC suggests **our building** be audited to the tune of \$100. Matter was turned over to Harris.
- CLERK. 1. As of today, the first day of filing for the April elections, only Jack Dayan has filed for trustee and I have filed for clerk.

ZBA Tary Fischer (Lot 16, Joy Lane) returned to appeal the Board's decision at the last meeting. he has since received Ray Glass' approval on the revised plans. Harris moved with a second from Shields not to approve the variance until the Board hears from the ZBA. CARRIED BY VOICE

MEETING OPENED TO PUBLIC. 1. Mr. Rork advised the Willow sledding hill was still being used. He also said the No Sledding Sign was no longer there.

2. June Kiebler requested the Board to contact the Park District showing their concern over the 236 acres Meadowdale raceway which is being sold. Thomas moved with a second from Hoff to encourage the Park District to purchase that property to keep as open space. Aye 3, Nay 1 MOTION CARRIED

ATTORNEY Harris moved with a second from Thomas to extend the approval of the final Plat for 180 days. Harris, Thomas, Hoff Shields, aye MOTION CARRIED

ENGINEER 1. Whiston introduced Chuck Mall who will be attending to the sewer district. His number is 426-3290.

- 2. Both gravity lines are in.
- 3. West Dundee Administor Bill sommer will present our request for additional sewer capacity tonight at the W.D. Board Meeting tonight per Peterson's January 14, 1987 letter.
- 4. Whiston will send estimate for updated Sleepy Hollow maps

TREASURER 1. Shields moved with a second from Harris to approve bills in the amount of \$49,907.59 less \$3,200.00 to American Municipal Software. Shields, Harris, Hoff, Thomas, aye. MOTION CARRIED

- Whiston has recalculated the Land/cash donation from Windsor I to be \$11,484.62.
- 2. Saddle Club. An ordinance will be put forth at the next meeting concerning signs. Thomas moved with a second from Hoff to advise Pulte that our Board must approve the physical structure of the signs; and if unacceptable, to Pulte, then Pulte must pay to install consistent signs throughout S.H. aye 3 abstain 1. MOTION CARRIED.
- 3. **SNOWPLOW** Out of 4 trucks 2 old-old, and 2 new-old, 2 are in very rough condition. One of the old-old ones needs \$2,000 to repair it. Harris suggested we retire it and use the parts. He also suggested we sell the FWD and purchase a new-new 1 ton dump for \$18,000.
- 4. The problem of **plumbing inspecte**r is being dealt with.

FINANCE- Shields wants to turn back the utility module to

American Municipal Software. It is too complicated and not trustworthy to deal with the water bills. Shields moved with a second from Thomas to offer \$600 for Accounts Payable to American Municipal Software and reject the rest of the system. Shields, Thomas, Harris, Hoff aye MOTION PASSES

HEALTH AND SEWER - Calculation have been done on the \$20,316.84 refund.

POLICE - 2 officers are being trained.
