4;. Lake Sharon was treated with copper sulfate only before July 4th. Harris is looking into purchasing fish to eat the vegetation.

FINANCE Rjon Panning's suggestions for the tax levy were presented. They show a 25% increase in Request, \$208,000, over the '86 Extension, \$166,000. Truth in Taxation Hearing will be held at 7:15PM August 17.

WATER 1. Bids were presented for 5/8" water meters with remotes. Fohrman \$55, Water Products \$52.50, Sideners \$48.60. Dayon moved with a second from Harris to purchase 60 5/8" meters with remotes from the low bidder, Sideners, for \$48.60 each. Dayon, Harris, Roberts, Shields, Ward MOTION CARRIED

2. Pressure problems on high side of Village during June were probably caused by an increase in water usage. In May we averaged 5500 of water gallons per hour; in June we averaged 13000 gallons per hour.

3. Engineer Whiston will put together a proposal for an Engineering study of the water system for the next meeting.

4. Algae in water system a week ago. Elgin let us know before it got here and system was flushed.

<u>BUILDING</u> 1. Our Zoning Map shows the 2 apartments on the south side of Willow as being zoned R-1 Zoning Board Heffron will investigate.

- 2. Harris moved with a second from Shields to require James Valente to reimburse the Village on Engineering costs incurred from bringing a main down to his property.CARRIED BY VOICE
- 3. Surrey Ridge V may have some soil problems. Plan Commission and Board so advised.
- 4. Board was also advised that according to the Subdivision Control Ordinance the developer must sod/seed the swale to the edge of the right of way.
- 5. Surrey Ridge 1 Credit Letter needs to be reinstated to cover seeding and lighting.
- <u>POLICE</u> 1. Police Committee reccommends keeping the best of the original 2 squad cars. Ward moved with a second from Shields to put one car up for bid with the right to reject any bids. CARRIED BY VOICE
- 2. Restrictions on the usage of the third car will be drawn up by the Police Committee.
- 3. There are proposed changes to Quad com? The fee change would probably result in no monetary change for us. Harris suggested we get a representative in from Quad Com to give a presentation on the changes. Ward will get a legal review by the Attorney.
- 4. Police Committee wanted a merit system for pay. However, the Board felt it wasn't a good idea in view of the fact we have a small Department.
- 5. The Police Committee with meet August 10 to interview Part time Police Applicants! There have been 17 applications submitted.

HEALTH AND SAFETY Discussion centered on the landscaping problems in the sewer area. Resident Brunner of Elm Court outlined the problems he has with his yard. The Landscaper has left and Gluth has said they, Gluth, have fulfilled the Contract. Trustees were advised to read the Easement Agreement. Harris advised we would have to be careful if we held back on the money to the Contractor. He also felt our Attorneys should be alerted and the Corps of Engineers be brought in.

NEW BUSINESS Bonnie Kalaway has moved out of town and is unable to be Deputy Clerk. Deputy Clerk has traditionally filled in as as recorder of the minutes at meetings the Clerk cannot attend. The Deputy Clerk has never received remuneration.

Harris moved with a second from Roberts to go into Executive Session for discussion of Personnel. 9:30.
