WATER 1. Water leakage on Hilltop that is being addressed.
2. Waiting for written report from Schoengart. There is a problem above us of a sagging central beam. Will be contacting architects to see if they would be interested in the work and obtain references. He will look to seeing how much a renovation will cost against building new. New building would cost \$45 to \$60 per s.f. Pre-fab will weep between the metal and the wall sand cause rust. Trustees agreed to wait for roofing until Johnson has looked into the renovating/new building costs.

<u>POLICE</u> 1 JETS- Ward advised that the Carpentersville/Countryside Fire Dept. wants a seat on the JETS Board and wants part of the JETS money for their dispatch center.
