JOHNSON MOVED WITH A SECOND FROM HARNEY TO ADOPT ORDINANCE NO. 92-24 ENTITLED AN ORDINANCE AMENDING TITLE 7, CHAPTER 5 OF THE VILLAGE CODE TO PROVIDE AN EFFECTIVE MEANS FOR PROTECTING THE WATER SUPPLY FROM CONTAMINATION DUE TO BACKFLOW OF CONTAMINANTS THROUGH THE CUSTOMER WATER SERVICE CONNECTION INTO THE PUBLIC WATER SYSTEM, WITHIN THE VILLAGE OF SLEEPY HOLLOW (THE CROSS-CONNECTION ORDINANCE). The Engineer will write a letter to the contractor of the board's decision. He will also see if we can find several small, local contractors to do the work instead.

AUDITORS REPORT - 8:00 P.M.

Bret Grishaber of Klayman & Korman was present to review the annual audit report and management comments. Complimented Ron, Mike, and Ellen on the job they have done. Noted that he received about 99% of the audit information from Ellen. We have a very strong surplus cash position, although major allotments are budgeted for the renovations that have been delayed by the gas tank contamination. Also noted that the sewer fund retained earnings show a deficit balance because of the depreciation expense, but is not a reason for concern. Management The auditors would like to see better accounting of the ticketing in the AWT program and a segregation of the duties in the building department.

TENNIS MOVED WITH A SECOND FROM SHIELDS THAT THE POLICE CHIEF AND THE TREASURER DEVELOP A MONTHLY ACCOUNTING PROCEDURE FOR USE OF AWT AND RELATED CASH RECEIPTS AND THAT THIS PROCEDURE BE DOCUMENTED IN WRITING AND PRESENTED TO THE TRUSTEES PRIOR TO THE FIRST MEETING IN DECEMBER. MOTION PASSED BY VOICE.

TENNIS MOVED WITH A SECOND FROM JOHNSON THAT THE BUILDING OFFICER AND TREASURER DEVELOP A MONTHLY ACCOUNTING PROCEDURE FOR USE OF BUILDING PERMITS AND RELATED REVENUES AND THAT THE PROCEDURE BE DOCUMENTED IN WRITING AND PRESENTED TO THE TRUSTEES PRIOR TO THE FIRST MEETING IN FEBRUARY, 1993. MOTION PASSED BY VOICE.

TREASURER:

1. Add Elgin water for \$16,446.73, delete leak detection service for \$633.60 and Gervasio/CMT for \$749.00. Trustees questioned the amount of money spent on Carol Crest Court beautification (over \$1,400). It was requested that future beautification project plans and proposed costs be presented to the board prior to actual installation. TENNIS MOVED WITH A SECOND FROM HARNEY TO APPROVE THE WARRANTS AS REVISED IN THE AMOUNT OF \$59,680.63. AYE: TENNIS-HARNEY-JOHNSON-ROBERTS-SHIELDS-WILLIAMS. MOTION PASSED.

*****OPEN TO THE PUBLIC****

1. Barbara Fergason, President of United Way of Dundee Township, and Patrick Sharpe, Campaign chairman, spoke about the agencies that they support. The Board felt we should encourage support of United Way in the newsletter. They hope to raise \$125,000 with fund raising costs of about \$7,000. TENNIS MOVED WITH A SECOND FROM JOHNSON TO PROCLAIM THE WEEK OF OCTOBER 11TH THROUGH OCTOBER 17TH, 1992 AS UNITED WAY WEEK IN THE VILLAGE OF SLEEPY HOLLOW. MOTION PASSED BY VOICE.

ROADS & PARKS:

- 1. Tom's Tree Service has not returned to finish work at Rainbow Creek. Someone else has finished the work.
- 2. Some of the part time police officers have expressed interest in helping with the snow plowing when the need arises. Trustee Harney will work out the personnel details with Chief Montalbano.
- 3. A driveway culvert needs to be reset on Maria Court to prevent pooling of water in a resident's yard. Our Engineer has estimated the cost at about \$1,000, and Geske has agreed to do the work for time and materials. This problem is not the fault of the Village. The middle of the cul-de-sac is being raised 5" as part of the MFT work, and the water will then drain to the resident's culvert.
- WILLIAMS MOVED WITH A SECOND FROM HARNEY TO PROCEED WITH REPAIRS TO THE DRIVEWAY CULVERT AT 1911 MARIA COURT AT A COST NOT TO EXCEED \$1,000, AND TO ATTEMPT TO RECOVER THE COSTS FROM THE BUILDER. MOTION PASSED BY VOICE.
- It was suggested we have the grades on new property certified by an engineer before the occupancy permit is issued to prevent problems of this type in the future.
- 4. We have received the appropriate bid information from the Engineers on the work to be done at the Saddle Club entrance. Bids are going out.
- 5. The lawn mower tractor should be advertised in the newspaper, requesting sealed bids.
- 6. The Bluffs will be plowed by the builder this winter.

FINANCE:

1. A report from ERM is ready to be submitted to the State. To date, we have authorized \$28,015 to correct the problem; the estimated total to complete the project is \$31,669.30. TENNIS MOVED WITH A SECOND FROM HARNEY TO PAY THE AUGUST INVOICE OF \$5,066 WITH THE NEXT WARRANTS, AND THAT THE OVERALL PROJECT BE AUTHORIZED TO INCREASE TO \$31,669.30. AYE: TENNIS-HARNEY-JOHNSON-ROBERTS-SHIELDS-WILLIAMS. MOTION PASSED.

WATER:

- 1. We have not yet received plans for the flow restrictor from CMT.
- 2. No written report has been sent by the water leak detection service. Art has started repairs on the leaks.
- 3. The possibility of a third pressure zone is not being pursued because of the very high cost involved. In the interim, we can try increasing the pressure on the pressure reducing valves. Getting a second connection with Elgin along Sleepy Hollow Road would probably also help the pressure problems.

POLICE:

- 1. Cable Committee: Approval of the by-laws will be discussed at the next meeting.
- 2. Beautification: Money is available in the budget for materials to rebuild the Deer Lane planter, but not for labor. The residents of the block have agreed to do the work if we supply the materials.
- 3. Some residents voiced concern about the police stopping a homecoming float on a trailer and possibly issuing a ticket. It was requested that the Chief review the matter and report back to the board.
- 4. Comment was made about vehicles passing on the right, heading west on Route 72, at Sleepy Hollow Road. The area on the right has been asphalt patched (not by us), giving motorists the impression it is permissible to pass on the area. We should ask IDOT to install a sign indicating that passing is not allowed.
