Both President Shields and Trustee Tennis called Bill Payne. His firm's decision to resign did not change. TENNIS MOVED WITH A SECOND FROM DEBOLT TO ACCEPT WITH REGRET AND APPRECIATION THE RESIGNATION OF SAMELSON, KNICKERBOCKER AND PAYNE EFFECTIVE NOVEMBER 30, 1995. MOTION PASSED BY VOICE VOTE. Treasurer Panning was requested to obtain a list of all legal hours over the past year and one-half, broken down by area of law, to better enable potential firms to submit proposals. Trustee Tennis has done some research concerning potential law firms. He has found a firm in Elburn that may be appropriate for our needs and distributed their firm resume. President Shields and Trustee Tennis will meet to discuss law firms and bring recommendations to the next meeting.

- 2. We need to bring Rob Robert's building phone line to the village hall, which will require an additional module. TENNIS MOVED WITH A SECOND FROM DEBOLT TO ACCEPT THE VILLAGE TREASURER'S RECOMMENDATION TO PURCHASE THE 206E MODULE FROM BCI FOR \$420 AND AUTHORIZE AMERITECH'S LINE MOVE TO THE VILLAGE HALL. AYE: TENNIS, DEBOLT, HARNEY, WILLIAMS. MOTION PASSED.
- 3. The release of remaining funds to Windsor on the Deer Creek project will be delayed since Trustee Fuqua has not yet reviewed the completed project.
