# REGULAR MEETING **MINUTES**

#### TREASURER:

- 1. Add \$100 to North Suburban Library System to establish a new virtual domain on the web for the Village. Briefly discussed our current web page. Questioned the repairs to the cut line by Utility Dynamics. This cut line was not their fault and we will pay the cost of repairing the line. CZERNIAWSKI MOVED WITH A SECOND FROM DEBOLT TO APPROVE THE FEBRUARY 11, 1999 WARRANTS IN THE AMOUNT OF \$76,321.62. AYE: CZERNIAWSKI, DEBOLT, HARNEY, MERKEL, NEMEC. MOTION PASSED.
- 2. Trustee Czerniawski noted that the nine month financial statements show that everything is doing fairly well.

# **HEALTH & SANITATION:**

- 1. Trustee Harney thanked Ellen Volkening for doing the work to have the carbon barrels removed from the Village.
- 2. Trustee Nemec met with a playground company rep concerning the playground equipment at Sabatino Park. An estimate to upgrade the playground equipment is \$25,000. The current playground is 15-20 years old and has some safety hazards to children. The Park District is willing to assume maintenance responsibility for our parks if we enter into a lease agreement with them for these parks. The Board authorized Trustee Nemec to discuss this with Park District officials and report back to the Board.

#### BUILDING:

- 1. HARNEY MOVED WITH A SECOND FROM CZERNIAWSKI TO APPROVE ORDINANCE NO. 99-13 ENTITLED "AN ORDINANCE AMENDING BUILDING REGULATIONS IN THE VILLAGE BY ADOPTING THE BOCA NATIONAL FIRE PREVENTION CODE, TENTH EDITION, 1996, WITH CERTAIN EXCEPTIONS". AYE: HARNEY, CZERNIAWSKI, DEBOLT, MERKEL, NEMEC. MOTION PASSED.
- 2. The Kane County Council of Mayors has formed a bicycle and pedestrian committee which will meet on February 24<sup>th</sup>. Trustee Harney will try to attend this meeting.

- 1. Resident Walt Heffron suggested an orientation program for new trustees to learn the many responsibilities of their new position. Board discussed and a work session with the current board of trustees after the election was suggested. The new trustees should review the Village code book, which they will receive after the election.
- 2. Jeff Seiler asked the Board to consider the ramifications to all area residents when they make their decision on the Joy Lane intersection widening which he thought would increase traffic through the Village. However, Trustee DeBolt pointed out that even after widening there still will be only one lane coming into the Village at this intersection, the same as now. Board briefly discussed, along with speed problem on Joy Lane.

#### **NEW BUSINESS:**

1. Joe Nemec discussed a more even distribution of trustee responsibilities; roads and parks has more work than some other trustee positions. Trustee Harney suggested new trustees attend Illinois Municipal League seminars/classes available to new trustees.

2. Trustee Harney informed the Board that the flood plain audit involving four homes is almost complete;

only one house is still open in this audit.

- 1. The executive minutes of February 1, 1999 were discussed and should be amended by including in paragraph 1 the following sentence: "Mr. Tousey should also agree to the same billing terms as Mr. Schuster as far as fractions of an hour and we should obtain all billing rates in writing." MERKEL MOVED WITH A SECOND FROM CZERNIAWSKI TO APPROVE THE FEBRUARY 1<sup>ST</sup> EXECUTIVE MINUTES AS AMENDED. MOTION PASSED BY VOICE VOTE WITH DEBOLT AND NEMEC ABSTAINING.
- 2. Trustee Harney said the Village's insurance may pay costs to defend Sue Harney and Joel Kruse. Mark Schuster has sent them a letter but it has not yet been received so we don't have their response. The Fahy matter is up in court and we will obtain a continuance until we know the answer. Sue Harney said she was never personally served with the lawsuit from Fahy and there was some question if there was proper service.
