1. The 2002 water main improvements are almost complete. At Jaclay and Thorobred, corrective drain/reswaling work is necessary to prevent standing water. We must defer something else in the budget to pay for this additional work. - 2. Linda Nuneman of Sharon Drive discussed several concerns with the plans submitted for the development of the Michalski property, including errors on the proposed plans and proper resident notification of the upcoming hearings.
- 3. Mike Pugliese of Sharon Drive spoke against the proposed Michalski development and notification to residents. He is concerned about the proposed road, surrounding property values, and commercial development.
- 4. Jay Bjork, as representative for the Service Club, advised the Board of the Christmas tree lighting to take place December 8th at Sabatino Park, beginning about 4 p.m.

PARKS, ROADS & STREETS:

- 1. The Green Communities facilitator interviews have been rescheduled to December 4th at 7:30 p.m.
- 2. The Engineer recommended that the Locust/Willow failing storm sewer should be replaced rather than repaired and has requested direction from the Board on proceeding. The Village should determine if MFT funds are available for this project before advising the Engineer.
- 3. The leak detection service discovered a leak on Hilltop Drive in Saddle Club. The road will be opened Thursday to pinpoint the exact location and make repairs. It should take no more than a day.

FINANCE:
