ATTORNEY:

- 1. ENGINEER:

- 1. The contracts for Jelke Creek have been sent out for signature. The contractor prefers to re-route the creek during the project, rather that de-watering the creek. This will require permission from the adjacent homeowner and the Kane County Water & Conservation District. A pre-construction meeting will be held in the near future.
- 2. Regarding the phosphate program, U.S. Filter was in the Village and was not familiar with the set up. They intend to contact the City of Elgin and then get back to the Village.
- 3. The NPDES Phase 2 permit is due to the IEPA on March 10th. The engineers can prepare the report for about \$1,500. COMMENTS FROM THE PUBLIC:

- 1. Linda Nuneman of Sharon Drive stated that she was advised by the Dundee Township Supervisor that they have reserved \$250,000 toward the purchase of the Michalski property. She asked the Board to express support to any agency considering purchase of the property and distributed a newspaper article about open space in the county.
- 2. Mike Ander of Sharon Drive noted that many residents are confused about the Village tax referendum and suggested the Village explain its financial situation clearly to the residents prior to the election. He also made presentations to several state agencies/organizations on the Michalski property who sent letters urging the Village to preserve the Jelkes Creek area and prevent any development of the area.
- 3. Gene Karl of Jaclay Court did his own traffic study of Route 72 and offered a copy of his results. He expressed his concern for the amount of traffic and how development of the Michaelski property would further impact the traffic congestion and safety.

PARKS, ROADS & STREETS:

- 1. The SmithGroup JJR contract was signed and a meeting may be held next week on starting this project.
- 2. The Kane County Dept. of Transportation has submitted the final draft of the county bike path and requested comments.
- 3. There will be another informal coffee with the residents on March 8^{th} at 9:30 a.m. to discuss the tax referendum and other Village issues.

FINANCE:
