- There is a Quad Com Jets board meeting on October 29th. President Pickett and Trustees Finney and Wind attended the Quad Com meeting last week regarding the options for their 12 year old 911 system and plans to purchase a new system at a cost of about \$1,300,000. They will ask Quad Com residents for an increase in their telephone land line charges in a 2004 or 2005 referendum to help fund the new system.

information in time to make a decision.

PLAN COMMISSION:

ZONING COMMISSION:

Chairman Art Neil noted there is a public hearing on November 13th to discuss various sign issues, permitting restaurants in the Village, and considering 24-hour drive through facilities. They have not yet received any recommendations from the Plan Commission on these items.

The Village's old P.U.D. ordinance was located and will be reviewed. Research concerning a P.U.D. 2.

anner will be put on hold until the public hearing is concluded.

Mr. Neil said the Village currently allows financial institutions. However, they bring no revenue to the Village and other communities have excluded them through ordinance. The Board agreed to this idea and directed the Zoning Commission to proceed to amend the ordinance to reflect this decision.

)ZBA:

No report.

Heide Files, Planning and Programming Manager with the Kane County Department of Transportation, made a presentation of the County's 2002 planning area study. She described the process in developing the final plan to handle increasing development in the area on the county's roads and also answered questions from the Board. Ms. Files said that Sleepy Hollow Road is a "collector" road, but there are no plans to widen or improve it. She left a sample resolution and asked that the Board consider passing the resolution in support of this plan.

ATTORNEY:

The draft ordinance on the ZBA secretary's duties will be discussed at the next meeting.

ENGINEER:

DIRECTOR OF FINANCE:

COMMENTS FROM THE PUBLIC:

- 1. Wally Sajdak of Churchill Court read a statement with his concerns if the Saddle Club Park is developed pursuant to the Green Communities grant. He also noted the park area is not regularly maintained.
- 2. Joe Rago of Geneva introduced himself as a candidate for the office of Kane County State's Attorney and gave a brief history of experience and goals for the office.
- 3. David and Michelle Skolozynski of Churchill Court, who applied for a variance and had a hearing on October 9th, asked the Board to allow the variance. President Pickett advised that this matter would probably be discussed at the November 3rd meeting.
- 4. Kurt Becker of Sharon Lane urged the Board to maintain the unique rural character of Sleepy Hollow as the Village's founders planned and not allow any commercial development in Sleepy Hollow.

PARKS, ROADS & STREETS:

1. Trustee Wind is meeting with the Village Engineer this week to discuss MFT projects.

WATER & SEWER:

No report.

POLICE & PUBLIC SAFETY:

1. The Chief attended the Eagle Scout ceremony for Corey Shoop who presented the Village with a certificate of appreciation for assisting Corey with his project. He also presented Chief Montalbano with a rommet from a flag flown by our air forces during the war in Iraq.

The Police Dept. is sending two officers to a Kane County seminar on animal health and welfare.

PUBLIC BUILDINGS & ENVIRONMENTAL:

BUILDING & ZONING ENFORCEMENT:

- 1. The Village has received complete plans for the new house construction on Beau Brummel and a permit has been issued.
- 2. Language is being drafted concerning height restrictions on homes in the R-1 district.
