COMMENTS FROM THE PUBLIC:

1. Bill Grupp of Beau Brummel noted that after the recent accident at the Randall/Route 72 intersection, rerouted traffic, including trucks, flowed down Joy Lane and through the Village non-stop for four hours. President Pickett will address the problem with the proper authorities to prevent this from occurring again.

FINANCE:

1. Trustee Ziemba explained that the Finance Committee would like to increase the capitalization threshold from \$1,000 to \$5,000 for machinery and equipment. This change will not affect the Village budget. <u>ZIEMBA MOVED WITH A SECOND FROM PRIGGE TO CHANGE THE CAPITALIZATION THRESHOLD FOR MACHINERY AND EQUIPMENT FROM \$1,000 TO \$5,000. MOTION PASSED.</u>

PUBLIC BUILDINGS & ENVIRONMENTAL:

- 1. Mona Auer advised Trustee Prigge that the creek is filling with sediment. He walked the area, but feels it may simply be a natural build-up over time. Mona has contacted local professionals to review the situation and give an opinion.
- 2. A section of the bridge on Sleepy Hollow Road has broken brick facing. This has been reviewed by the engineers who advised that there are no structural concerns, it is only cosmetic. They are contacting the manufacturer to see if the repairs will be covered by any warranty.
- 3. A dead tree by Mona Auer's property will be removed with her approval.

BUILDING & ZONING ENFORCEMENT:

OLD BUSINESS:

- 1. The proposed cell tower would be 125' high and be installed by the salt bin. The cell phone company has requested a response from the Village on their interest. There was some concern from board members about the effects of the radio waves. The Board decided the cell phone company should attend a meeting to make a presentation and answer questions.
- 2. President Pickett met with the Sleepy Hollow Road homeowner who removed trees from Village property. A hand-drawn proposed landscape design was reviewed by the Board. Trustee Prigge did not feel the proposed plantings were sufficient and will discuss it with the homeowner. It was felt there should be additional large trees planted.
- 3. There has been no further communication from the homeowner with the water problems in Deer Creek.

ZIEMBA MOVED WITH A SECOND FROM PRIGGE TO AMEND THE AGENDA TO RETURN TO PUBLIC COMMENTS. MOTION PASSED.

Resident Stacy Pierce of Carol Crest was present with her young sons and friend Angelica Thomas to ask about an ordinance that frogs cannot be caught and changing the ordinance. She said a resident has bothered her sons and called the police to report them for their actions. She said the boys have numerous store-bought pets in their home and do not keep the frogs, they release them back into the habitat. They are very interested in frogs and other wildlife in the Village and do not keep or harm them. The woman has complained to her sons on several occasions since last year about what they are doing.

VILLAGE OF SLEEPY HOLLOW EXECUTIVE MEETING MINUTES

JUNE 18, 2007

The executive session of the Sleepy Hollow Board of Trustees was convened at 8:17 p.m. for the purpose of reviewing and approving executive minutes and discussing threatened litigation pursuant to §\$2(c)(21) and (11) of the Open Meetings Act. In attendance were President Pickett; Trustees Fudala, Prigge, Wind, and Ziemba; Police Chief Montalbano, and Clerk Olson.

1. The house at 1022 Beau Brummel has allegedly been used as a "boarding house", although the Village has not had proof or evidence. Village ordinances do not permit renting of rooms. Chief Montalbano briefly explained the recent history of this house where they have responded to several calls since its sale in 2004 to a convicted sex offender and re-sale to the current owner, John Long, in 2006. During the most recent police incident, individuals at the house admitted they were the property manager and renter. Attorney Schuster submitted a memo concerning this matter and the legal action necessary, along with his estimated fees which could exceed \$17,000. He noted that the house is currently in foreclosure proceedings. The Board would like to take some less expensive steps first. They would also like to see if the foreclosure may eliminate our need to proceed with a lawsuit if the owner is evicted. The Board concurred they would like the attorney to first send a letter to the homeowner. They would also like to find out more about the foreclosure proceedings and the Clerk offered to find out what she could and advise the Board. (Chief Montalbano leaves the meeting at 8:45 p.m.)

2. <u>ZIEMBA MOVED WITH A SECOND FROM WIND TO APPROVE THE EXECUTIVE MEETING MINUTES OF APRIL 16, 2007 WITH THE CORRECTION OF THE WORD "THEN" TO "THERE" IN PARAGRAPH 1. MOTION PASSED,</u>

3. The Board conducted a semi-annual review of the executive minutes proposed for release to the public and agreed that only the December 18, 2006 executive meeting minutes would be released at this time. All other minutes proposed for release relating to a former police officer and former village president should remain confidential.
