Sleepy Hollow School and the Park District have approved use of their parking lots for the event and 65-75 vehicles are anticipated. Mr. Almasri gave the Board further details of the event and answered questions from the Board. All fields will be in use by 27 teams and there will be one police officer dedicated to the tournament, expected to run from 9 a.m. to 5 p.m. Trustee Fudala was not in favor of the tournament as he felt the cleats would damage to the fields. The insurance certificate and estimated deposit of \$2,960 will be delivered to the Village before Saturday. ENGINEER

1. The contractor for the water project has been working on the fire hydrants and other remaining work for the project. The fire department has asked that the Village replace an additional 13 old hydrants since an adaptor must be attached each time the department needs to use those hydrants. There are also leaking issues with these hydrants. The Village has three additional older hydrants in the village that should also be replaced which will complete upgrades on all hydrants. (Trustee Ziemba arrived at 8:05 p.m.) The contractor can do this work but may not be able to complete it all immediately. Public Works has also previously recommended the Village install two pressure reducing values. The cost for this additional work will bring the total project cost to about \$1,200,000, still under budget. Seiler moved with a second from Nemec to authorize the additional work for the fire hydrants and pressure reducing values to complete the water system improvements. Aye: Seiler, Nemec, Ziemba. Nay: Fudala. Motion passed. The engineer noted that the landscape restoration work will be completed based on the weather/rain.
