- 3. <u>Seiler moved with a second from Ziemba to approve the water and sewer accounts to be written off in the amount of \$204.10. Aye: Seiler, Ziemba, Merkel, Nemec. Motion passed.</u>

Nemec moved with a second from Ziemba to amend the agenda to move the 8 p.m. presentation to now. Motion passed unanimously. Cathy Story was present on behalf of Crichton Enterprises, and requested permission to hold a farmer's market in the parking lot of 1700-16 Main Street. Vendors would sell their own goods on the property. The hours would be 8 a.m. to 4:30 p.m. on Saturday and possibly Sunday and be held weather permitting. Nemec moved with a second from Seiler to approve the request for a farmer's market at 1700-16 Main Street as outlined in the April 6, 2018 letter to the Village. It would be set up similar to the open market in East Dundee. There would be signs similar to those used by Ambrose Greenhouse that previously rented the space. One of the vendors may sell fresh fruit and vegetables. There will probably not be sales tax for the Village. Motion previously approved.

- 2. <u>Ziemba moved with a second from Seiler to approve the Fiscal Year 2019 Annual Operating Budget.</u> Trustee Ziemba made brief comments regarding the budget. He also noted that the resurfacing of Sleepy Hollow Road could cost over \$500,000. This project would be spread over a few years and the Village will apply for grants as well. <u>Aye: Ziemba, Seiler, Merkel, Nemec. Motion passed.</u>

WATER AND SEWER

1. Water Services has been checking for leaks in the Village and have found at least two additional leaks. Efficiency is rising since some leaks have been repaired.

POLICE AND PUBLIC SAFETY

1. Chief Linane briefly reviewed the Illinois traffic stop report regarding racial profiling and noted that Sleepy Hollow meets the state benchmark for individuals stopped in the Village. The Chief also briefly reviewed the monthly police activity report and compared some areas with last year's totals.

2. The new owner of the property on Sleepy Hollow Road that wants to trim/remove some trees will submit a report from an arborist regarding the trees and will attend the next board meeting.
