## VILLAGE OF SLEEPY HOLLOW MEETING - OCTOBER 10, 1958

The meeting was called to order at 8:00 P.M. on October 10, 1958. First order of business was the Roll Call which answered as follows:

Floyd Falese Present Keith Stewart Absent Eugene Unterschuetz Present James jordan Present David B. Garrison Present Elmer Houlberg Present Stanley Jensen Present David E. Garrison Absent

Also present at the meeting were Francis Weaver, Police Magistrate, Robert Stitgen, Village Marshal, Malcolm McCuaig, Attorney and Arthur Lindemann, Treasurer.

In the absence of David E. Garrison, Elmer Houlberg was assigned to take the minutes of the meeting. The minutes of the previous meeting of July 31, 1958 were read and approved.

Floyd Falese discussed the problem of snow removal within the Village of Sleepy Hollow during the coming winter months. Jim Jordan read a proposal submitted by the Dhamer, Lauger Landscape Co., Inc. and the snow removal and proposal were discussed by the members present. Gene Unterschuetz requested that snow plowing of Sleepy Hollow Road be included. It was agreed that if township plows will not clear Sleepy Hollow Road within the village limits, that Dhamer, Lauger Landscape Co., Inc. would see that the snow is removed and make an open road available to the residents within the Sleepy Hollow Road. Motion was made by Jim Jordan to accept the hourly agreement of snow removal as submitted and this seconded by Stan Jensen - Snow Removal Proposal, Exhibit A.

The Al Kirkland Report was discussed and the \$1400.00 bill was also discussed regarding payment for legal services rendered. Floyd Falese suggested writing Mr. Kirland acknowledging receipt of the bill and suggesting that we pay off this bill in installments as money becomes available. This letter will be written by Floyd Falese in order that a clear understanding will exist between the village and Mr. Kirkland. David B. Garrison made a motion that \$400.00 be paid on the Kirkland bill within 30 days. This was seconded by Eugene Unterschuetz. Included in this motion was a request to pay the bill to Great Lakes Fire Equipment Company, Invoice No. 04632 dated October 6, 1958 in the amount of \$145.00 and Art Craft Press for one hundred "NO HUNTING" signs invoice dated October 9, 1958 in the amount of \$10.00.

Eugene Unterschuetz brought up the question of de-annexation from West Durdee of property on which the Sleepy Hollow Motel is located. It was pointed out that this was a function outside the jurisdiction of the Village of Sleepy Hollow and it was further pointed out to the members present that representatives of the Mid-Union Indemnity Company and the Sleepy Hollow Motel would get together to petition such de-annexation. Further discussions of this proceeding was dropped from the meeting since it did not relate to village business as such.

Eugene Unterschuetz then discussed the Dundee Countryside Association which has been formed by residents located in the various surroundings around the Village of Sleepy Hollow and pointed out that this association is to be a volunteer watchdog organization devoted to the protection of esthetic and property values within the area as well as working actively to improve these values. Membership form which is being used by the Dundee Countryside Association was submitted to the meeting for review in order that all members might understand the working and reasons for this association. It was agreed that the Village of Sleepy Hollow co-operate with and work with the Dundee Countryside Association on all matters that might affect the residents of the Countryside as well as the residents within the village limits. Exhibit B is a copy of the Membership Application referred to.

Building Inspections and Building Permits were then discussed by Floyd Falese. Then handling of issuance of permits was questioned and also the fact that inspection reports were not being cleared promptly tended to, making confusion where the Building Committee was involved. David B. Garrison outlined the various procedure followed in making inspection and it was pointed out as following Kane County Codes as adopted by the Village of Sleepy Hollow at a previous meeting. It was suggested that these codes and procedures be followed as outlined in order to avoid any further confusion.

Ordnance 58-5 was then read which is the prohibiting of the use of fire arms within the city limits of the Village of Sleepy Hollow. Motion was made by Jim Jordan to accept the motion as submitted and this was seconded by Stan Jensen.

Roll Call Vote: Ayes 5 Noes 0

Petition for Annexation dated October 10, 1958 and signed by Floyd Falese and Jacqueline Falese of Unit #9 of part of Section #28 into the Village of Sleepy Hollow was next submitted for consideration at this meeting. Ordnance 58-6 was read by Malcolm McCuaig covering annexation of property described in the petition. Motion was made by David B. Garrison to accept the petition and Ordnance 58-6 as read and motion was seconded by Gene Unterschuetz. Roll Call Vote indicated 5 Ayes and 0 Noes.

Floyd Falese next pointed out that a bulletin board has been donated by Mr. Kohler and this bulletin board will be used for posting various notices and information pertaining to various activities wherein the residents of the village will have an opportunity to see them posted.

Motion was made by David B. Garrison to close the meeting. This motion was seconded by Jim Jordan. This was approved by a vote of 5 Ayes - 0 Noes. Meeting was adjourned at 10:15 P.M.

## PETITION FOR ANNEXATION

To the President and Board of Trustees of the Village of Sleepy Hollow, Kane County, Illinois

## SNOW REMOVAL AGREEMENT

Floyd Falese - Mayor Village of Sleepy Hollow Dundee, Illinois

This shall serve as an agreement between the Dhamer-Lauger Landscape Co., Inc. and the Village of Sleepy Hollow.

This agreement shall consist of the following provisions governing snow removal services:

An individual authorized by the village shall determine when snow removal services are required, and so direct the work to be done. The street easement, approximately 20' from the roadway edge, is established primarily for surface drainage facilities as well as a place for the disposal of snow from the street surface. Consequently we will not be liable for any damage ensuing from our proposed operations to landscape plantings, should heavy drifting be moved laterally onto the easement area.

Every effort will be made to prevent damage to ajoining turf area and to headwalls constructed on the street easement. Accordingly we will provide for each obstacle and at 100 intervals along the roadway edge, a temporary unobtrusive marker to serve as a guide for our operations.

We will provide the necessary equipment and labor to keep the designated streets open to two way traffic.

We will provide the necessary equipment to spread an abrasive, should icy conditions exist.

Continuation of Agreement - Page 2

For this service the rate shall be \$10.00 per hour for each unit in operation Aunit shall consist of a 2 ton dump truck, equipped with a highway type snow plow, and an abrasive spreader. In the event, the concentration of snow is such, that it must be loaded and truck from the area, a charge of \$5.00 per hour for the tractor, loader and operator will be made, in addition to the hourly rate of \$6.50 for the dump truck and operator.

This agreement shall remain in effect for the season of 1958-1959 snowfall.
