## VILLAGE OF SLEEPY HOLLOW Meeting of August 30, 1963

The regular monthly meeting of the Board of Trustees of the Village of Sleepy Hollow was called to order at 7:45 PM by Rauland Fischer, acting President.

Roll call was taken and answered as follows:

Minutes of the previous meeting were read and approved.

Mr. Cramer reported that the Village Fund raising party was scheduled for September 21 and that all committees had been appointed and were functioning.

Mr. Fischer reported that the census had been completed and the official returns showed 778 residents in Sleepy Hollow. In view of the fact that this figure was over the estimate, the Bureau of Census charged \$305.00 instead of \$285.00 as originally estimated. A charge of \$51.84 was also incurred in publication of a census notice in the Elgin Courier News.

Mr. Quigley read the Village Financial Report and was then authorized to pay the above census bills as well as approximately \$240.00° in miscellaneous invoices.

The Chairman of the Planning Commission was not present to give a report on the Whitney and the Countryside Manor Subdivisions.

Mr. Gordon Kosche read the suggested by-laws for the Park and Safety Commission. Mr. Jordan moved that these by-laws be adopted and was seconded by Mr. Knott. The vote of approval was unanimous. Mr. Kosche also submitted a list of signs which his commission feels are necessary in the Village. This list was turned over to Chief Sabatino who will go over it with Mr. Kosche and make recommendations at the next meeting.

Mr. Knott brought up the office which Suarez Brothers continue to maintain beyond the time set for its removal. Whief Sabatino was instructed to advise Suarez Brothers that they are in violation of their original agreement.

A formal report from the Glen Oak Club owners, which was to be submitted at this meeting, did not arrive. Mr. Fischer is to contact Mr. Kessler to ask him to attend the next meeting.

Mr. Strass reported that any state funds used for a Park District would necessitate opening the parks to general public use. Mr. Kosche asked Mr. Strass to look into special assessments for specific Park District use.

Ordinance 63-14 concerning unlawful entry into private property within the Village was read by the Clerk. Mr. Cramer moved for
