MINUTES OF THE REGULAR MONTHLY MEETING OF THE VILLAGE OF SLEEPY HOLLOW SEPTEMBER 12, 1966

The following are the minutes of the regular monthly meeting of the Village of Sleepy Hollow, September 12, 1966.

The meeting was called to order at 7:48 P.M. by Mr. R. Fischer. Roll call was taken and answered as follows:

The minutes of the last meeting were read by the clerk. M Strass noted that the word ordinance be changed to levy. Mr. Fischer made a motion that the minutes be accepted. Mr. Geis seconded. Roll call 5-0, l absent.

The minutes from the Special Board Meeting held on August 13, 1966, were also read. Mr. Geis made a motion that they be accepted as read. Mr. Quaine seconded. Roll call 5-0, 1 absent.

Mr. Fischer gave a brief report on the need for a new census at the present time. He estimated an additional annual increase of \$2,400.00 from the motor fuel taxes to the village. He also pointed out that the next census is not scheduled until 1970 and the village would be losing this additional income.

Mr. Hlavacek was introduced by Mayor Falese to explain the village's necessity of having the 5% utility tax. After his comments, the floor was open for general discussion. A representative from the gas company explained how the utility companies figure out

the percentage they charge for their accounting work. Mr. Strass then read Ordinance 66-7.

Mr. Hlavacek made a motion that it be accepted, and Mr. Lindemann seconded. Roll call was as follows:

The ordinance was adopted by a vote of five ayes, no nays, and one absent.

A letter was read from our Public Health Officer on the problem of water pollution on Mr. Kohler's patio. Copies of the letter to be sent to Messrs. Kohler and Suarz.

Mr. Quaine read the report on building permits issued for the month of August.

Mr. Hlavacek read the combined Treasurers report for the months of August and September in Mr. Quigley's absence. Certain bills were recommended for payment. Mr. Fischer made a motion that the recommended bills be paid. Mr. Geis seconded. Roll call 5-0, 1 absent.

A question was presented to the board on how a better control can be put on the type and style of houses being built in the Village. Floor open for discussion.

The floor brought up the subject of Chief Sabatino receiving an increase in salary with the additional funds from the Utility Tax.

Mr. Fischer made a motion that the Chief receive an additional \$150.00 a month retroactive to November 1, 1966. Mr. Lindemann seconded. Roll call 5-0, 1 absent.

A suggestion was brought up of having a Las Vegas Nite for the Village and having a specific goal in mind -- such as a tractor or a plow to help maintain our parks. Dr. Gale said this could come

as an activity of the club he is trying to form.

A brief discussion ensued on finishing the road work on Crane Drive.

Motion made to adjorn by Mr. Geis and seconded by Mr. Fischer. Time -- 10:05.
