MINUTES OF THE REGULAR MONTHLY MEETING OF THE VILLAGE OF SLEEPY HOLLOW

March 6, 1967

The following are the minutes of the regular monthly meeting of the Village of Sleepy Hollow, March 6, 1967. The meeting was called to order at 7:45 PM by Mayor Falese. Roll call was taken and answered as follows:

The minutes of the February 6 meeting were read by the clerk. Mr. Lindemann made a motion that the minutes be accepted as read. Mr. Quaine seconded.

Roll call 4-0, 2 absent.

It was noted that a loan was procured from the Algonquin State Bank at 4% interest. Mayor Falese co-signed for the village.

Mr. James Baugh donated \$50.00 towards the snow removal fund. A letter of thanks is to be sent to him.

Mr. Richardson of the Dundee Review was introduced by Mayor Falese.

Mr. Hlavacek read the treasurer's report for the month of March. It was decided to wait until Mr. Quigley's return before any bills are to be paid. It was also noted that we received 3 utility tax checks -- gas \$713.62, electric \$542.30, telephone \$288.98.

Mr. Quaine reported that 3 building permits were issued which amounted to the sum of \$555.00.

Mr. Lindemann read the Police Report for the month of February. The annual Police Report for the year 1966 was also read.

It was noted that there have been many compliants about dogs running loose in the Village. Several suggestions were given on how to handle the problem. It was decided that Chief Sabatino would warn the offending owners about letting their dogs run loose. A fine would be imposed if another warning is needed.

The sample ballot of the forthcoming election on the Trustees and Village Clerk was approved. A list of judges and a salary of \$15.00 was also approved. The judges for the election will be Mrs. Virginia Klopfenstein, Mrs. Lovey Marcus, Mrs. Lorraine Meyers, Mrs. Mary Eichler, Mrs. Lynn Van Poucke. Mrs. Byrle Strass will act as a stand-by. The referendum ballot was discussed.

Mayor Falese attended a meeting at Mr. Rodgers house regarding the liquor issue. A brief summary was given regarding this meeting, and the possibility of amending the liquor ordinance and adding a clause for package liquor sales. Mr. Strass discussed these two possibilities and also gave an explanation on the two different filing dates for petitions (60 days or 78 days.) Chap. 43, Sec 2.8-1 and Chap. 43 Sec. 167 of the Illinois

State Statue were quoted regarding this difference. He also suggested that an explanation of wet or dry town be put on the ballot.

Mr. Quaine made a motion that an explanation of what means a wet town and what means a dry town be put on the referendum ballot. Mr. Lindemann seconded. Roll call 5-0, l absent.

Floor was opened to general discussion. After a very lengthy pro and con discussion, Mayor Falese stated that when the petition with approximately 180 names was filed, the Swim Club felt they would not have the support of the Village residents, so they dropped the idea of serving liquor at the Swim Club and withdrew their proposal. Also, Mayor Falese stated that as long as he was the Village President, which made him the Liquor Commissioner, he would not issue a liquor license to the Club. He would only issued a license for the sale of package liquor in the proposed shopping plaza located east of the apartment buildings on Willow Lane.

A committee was appointed to work with Mr. Strass on amending the liquor ordinance. Mr. Rodgers was made chairman and Mr. O'Connor was to assist him. They are to appoint anyone else they might need.

Mrs. Burchinol was appointed as a judge on the referendum ballot.

Mr. Lindemann made a motion to adjourn the meeting. Mr. Quaine seconded. Time 10:50 PM.
