Mr. Falese read the census report. There are 1,329 residents in the Village.

Mr. Quaine reported nine building permits were issued, amounting to \$1,140.

Mr. Quaine read a letter regarding the zoning map of the village.
Mr. Baugh read a letter from Rakow Assoc. in regard to road work
on Locust and Willow Lane.

Mr. Strass gave a brief report on the water company.

Mr. Moyle has not submitted a financial report as yet.

Mr. Shields motioned that, "All invoices submitted for payment of building inspection fees must be submitted directly to the chairman of the Building and Zoning Committee. The chairman must approve payment of the invoice in writing prior to payment by

the Village Treasurer. All invoices must be itemized listing the address and owner of each property inspected." Mr. Baugh seconded. Roll call 4-0, 3 absent.

Chief Sabatino gave a brief report on the operation of the Police Department and the need of some new ordinances regarding fines.

Mr. Griffiths gave a report on the Park and Safety Commission.

A brief report was given on Las Vegas night.

Mr. Falese noted that the School Board was planning on building a 20 room school in Sleepy Hollow. They looked at the property (12-15 acres) on the south end of the Village on Sleepy Hollow Road, across from Hickory Hollow.

Mr. Baugh read a letter from the Illinois Chamber of Commerce addressed to the Police Chief.

Mr. Shields read a letter from Carpentersville regarding the payment of \$537 which the Village owes them since 1958. Mr. Shields motioned that we pay Carpentersville the amount owed and the normal monthly operating expenses. Mr. Quaine seconded. Roll call 4-0, 3 absent.

It was noted that Mr. Fischer should attend the Police Conference.

Mr. Quaine motioned that the meeting be adjourned. Mr. Baugh seconded. Time: 8:45 P.M.
