### ORDINANCE NO. 2023 - 7

#### **APPROPRIATION ORDINANCE**

An ordinance appropriating for all corporate purposes for the VILLAGE OF SLEEPY HOLLOW, ILLINOIS, for the fiscal year commencing on the 1st day of May 2023 and ending on the 30th day of April 2024.

BE IT ORDAINED by the President and Board of Trustees of the Village of Sleepy Hollow, Illinois:
