**AN ORDINANCE
AMENDING THE REGULATIONS FOR STOPPING, STANDING,
PARKING AND STORING OF CERTAIN VEHICLES, TRAILERS,
WATERCRAFT, SNOWMOBILES, AND OTHER ITEMS IN THE VILLAGE**

WHEREAS, the Corporate Authorities of the Village have in the past adopted certain regulations governing the stopping, standing and parking, and storing of certain vehicles, trailers, watercraft, snowmobiles, and other items in the Village; and

WHEREAS, some of said regulations were included in Title 8: Zoning; and

WHEREAS, the Corporate Authorities deem it to be necessary and advisable at this time to modify the regulations governing parking, stopping, standing, and storage of certain vehicles, trailers, watercraft, snowmobiles, and other items in the Village, in order to delete certain provisions related to such parking and storage from Title 8: Zoning, and to add certain provisions related to such parking and storage to Title 5: Traffic Regulations.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF SLEEPY HOLLOW, KANE COUNTY, ILLINOIS, AS FOLLOWS:

Section 1. The Sleepy Hollow Municipal Code, Title 5: Traffic Regulations, Chapter 3A: Stopping, Standing, and Parking, shall be and is hereby amended to add certain regulations governing the stopping, standing, parking and storage of certain vehicles, trailers, watercraft, snowmobiles, and other items in the Village, in words and figures as follows:

Section 2. After the effective date of this Ordinance, the provisions of Title 8: Zoning, Chapter 3: Residential Districts, Article 3A: R-1 Residential District, Section 8-3A-3(D): Parking Regulations, shall be deleted in their entirety from the Village Code.

Section 3. The provisions of the Village of Sleepy Hollow Municipal Code, Section 8-3A-8, shall be and are hereby re-numbered and amended as follows:

TITLE 5	TRAFFIC REGULATIONS
CHAPTER 3A	STOPPING, STANDING AND PARKING

SECTION 5-3A-9 PENALTY

A. Any person who admits, pleads guilty to, or is found to have violated the provisions of this chapter shall be subject to a penalty in accordance with the provisions of title 1, chapter 4 of this Code; except that, for any charge of violation of this chapter brought pursuant to the authority prescribed in title 1, chapter 12 "Administrative Ticket Program," of this Code shall be subject to the penalties prescribed therein.

Section 4. The Sleepy Hollow Municipal Code, Title 1: Administrative, Chapter 12: Administrative Ticket Program, shall be and is hereby amended to add certain regulations governing the stopping, standing, parking and storage of certain vehicles, trailers, watercraft, snowmobiles, and other items in the Village, to the other parking violations which may be charged said program, in words and figures as follows:

TITLE 1 ADMINISTRATIVE

CHAPTER 12 ADMINISTRATIVE TICKET PROGRAM

SECTION 1-12-1 ADMINISTRATIVE TICKET ("PV") PROGRAM

B. Other Parking Violations: Whenever a village police officer is authorized to arrest a person without a warrant for a violation, or otherwise observes a violation, of sections 5-3A-1 through 5-3A-8 of this Code, or any violation of the following sections of the Illinois Vehicle Code which have been adopted by the village pursuant to section 5-1-1 of this Code, said officer may issue a "PV" ticket in such form as approved by the chief of police setting forth the nature of the violation, and the date, time and location wherein the violation occurred; and shall serve same by personal delivery to the vehicle operator, if present, or by leaving same on the motor vehicle in question.

Section 5. Any and all ordinances, resolutions, and orders, or parts thereof, which are in conflict with the provisions of this Ordinance, to the extent of any such conflict, are hereby superseded and waived.

Section 6. If any section, subdivision, sentence or phrase of this Ordinance is for any reason held to be void, invalid, or unconstitutional, such decision shall not affect the validity of the remaining portions of this Ordinance.

Section 7. This Ordinance shall be in full force and effect from and after November 1, 2023, and after its passage, approval and publication in pamphlet form as provided by

law.



TITLE 5 TRAFFIC REGULATIONS

CHAPTER 3 TRAFFIC SCHEDULES

ARTICLE A SECTION 5-3A-8

SECTION 5-3A-8 VEHICLE PARKING AND STORAGE

- A: Definitions**
- B: Overall Limitation**

A. DEFINITIONS:

1. Where applicable, terms utilized in this article shall have the meanings ascribed to them in the Illinois Vehicle Code, the Illinois Boat Registration and Safety Act, and/or the Snowmobile Registration and Safety Act, respectively.
2. For purposes of this article, the parking or storage of a commercial vehicle, or a cargo, utility or storage trailer, at premises classified in a residential zoning district, by the owner or occupant of any residence on said premises, shall not constitute the making of a delivery or the rendering of a service at such premises.

B. OVERALL RESTRICTIONS:

1. One, and not more than one, of any of the types of items allowed and described in this Section may be parked or stored on any residential property in the Village at any one time. Provided, for purposes of this subsection, an appropriate trailer holding a type of allowable item (for example, a trailer holding a boat) shall not be considered a separate type of item.
2. At all times, any vehicle subject to the provisions of this Section requiring licensing, permitting, or registration with any governmental entity shall have affixed thereto and plainly visible a currently valid license, permit or registration.

C. COMMERCIAL VEHICLES AND EQUIPMENT:

1. The following shall not be parked or stored on any premises classified in a residential zoning district in the Village, i) except in an enclosed garage; or ii) except when involved in making a delivery to or rendering a service at such premises:
 - a) Any commercial vehicle with a registration plate designation of "D" or above;
 - b) Any commercial vehicle weighing more than 12,000 pounds; and

- c) Any type of equipment or tools utilized by a person in pursuit of a trade.
- 2. The following shall be exempt from the prohibition set forth in this subsection:
 - a) Any "pick-up truck," to wit: a light-duty truck, whether used for commercial or personal purposes, that has both an enclosed driver/passenger cabin and a cargo bed enclosed by three low sidewalls and a tailgate with no permanent covering (but which may include a removable covering).

D. WATERCRAFT:

- 1. A boat (including a boat on a trailer), or boat trailer, may be parked or stored on residential premises in the Village, but only under the following conditions:
 - a) The boat and/or trailer shall be no longer than twenty (24') feet in length as measured in accordance with the provisions of this subsection;
 - b) Between April 1 and October 31 of any year, the boat and/or trailer shall be parked or stored on the premises either on a paved driveway, or on a paved surface alongside the garage behind the building setback;
 - c) Between November 1 of one year and March 31 of the following year, the boat and/or trailer shall be parked or stored on the premises either inside the garage on the premises, or off the premises.
 - d) Such boat and/or trailer may be brought to and parked or stored at the property for a period of not more than three (3) consecutive days, but only for the purpose of loading or unloading for a specific trip, and not more than twelve (12) days total in any one calendar year; and only upon request to and permission from the Chief of Police or his/her designee.
 - e) The boat and/or trailer must be in operable condition;
 - f) Any boat when covered shall be done so with a cover designed and fitted for the specific boat to which it is attached;
- 2. A boat and/or trailer longer than twenty (24') feet in length as measured in accordance with the provisions of this subsection shall be parked at all times either inside the garage on the premises or shall be kept at a site off the premises.
- 3. Within 72 hours of being brought to and parked or stored at a residential property in the Village, any boat and/or boat trailer otherwise being parked or stored in compliance with this subsection shall be registered with the Village Police Department, on a form provided by the Village, such registration to include: the make, model, hull identification, license number, and maximum length of such boat measured from the farthest extension of the bow to the outside dimension of the motor; and/or such boat trailer, measured from the end of the trailer attachment to the outside dimension of the motor.
- 4. The Chief of Police or his/her designee, in his or her sole discretion, shall have the ability to grant, in writing, temporary and limited exceptions to the requirements of this subsection, based on individual requests and circumstances.

E. RECREATIONAL VEHICLES (RV):

- 1. A recreational vehicle ("RV") owned or operated by the owner of a residential property in the

Village may be parked or stored on the owner's residential premises, but only under the following conditions:

- a) The RV shall be no longer than twenty (24') feet in length according to manufacturer's specifications;
 - b) The RV shall be parked or stored on the premises either on a paved driveway, or on a paved surface; and
 - c) The RV must be in operable condition.
2. An RV longer than twenty (24') feet in length shall be parked or stored either inside the garage on the premises, or off the premises, with the following exception:
 - a) Such RV may be brought to and parked or stored at the property for a period of not more than three (3) consecutive days, but only for the purpose of loading or unloading for a specific trip, provided, such RV may not be brought to and parked or stored at the premises for more than twelve (12) days total in any one calendar year.
 3. An RV of any length and otherwise being parked or stored in compliance with this subsection shall first be registered with the Village Police Department, on a form provided by the Village, such registration to include: the make, model, and dimensions per manufacturer's specifications for length, width and height of such RV.
 4. An RV owned or operated by a visitor to a residential property in the Village may be parked on the driveway of such residence for a period of up to ten (10) days per visit, but for not more than twenty (20) days per year, subject to application filed with and approved by the Chief of Police or the Village Code Enforcement Officer in advance of each such visit.

F. CARGO, UTILITY AND STORAGE TRAILERS:

1. Except as otherwise provided herein, no cargo, utility or storage trailer shall be parked or stored on any property within the Village i) except in an enclosed garage; or ii) except when involved in making a delivery to or rendering a service at such property.
2. The Chief of Police or his/her designee shall have the ability in his/her sole discretion, to grant, in writing, temporary and limited exceptions to the requirements of this subsection, based on individual requests and circumstances.

G. OTHER WATERCRAFT, ALL-TERRAIN VEHICLES, GOLF CARTS, AND OTHER SIMILAR ITEMS:

1. Except as otherwise set forth in this article, no other watercraft, including but not limited to boats, canoes, kayaks, and jet skis, and no golf carts, all-terrain vehicles (ATV's), and other similar vehicles, including trailers designed to carry any such vehicles, shall be parked or stored on any lot or parcel of less than five (5) acres in area and classified in a residential zoning district in the Village, except as follows:
 - a) in an enclosed garage; or

- b) temporarily, for a period not to exceed twenty-four (24) hours, in a driveway or parking lot on a parcel classified in a residential zoning district; and not more often than two times in a calendar year.
2. Watercraft, including but not limited to boats, canoes, kayaks, and other non-powered watercraft, and jet skis, may be kept or stored on the surface or on the shore of a private lake, in an area or at a location designed for such purpose.

H. SNOWMOBILES:

1. Snowmobiles, alone or on a trailer that is specifically designed and manufactured to transport snowmobiles) not more than sixteen (16) feet in length, or such snowmobile trailer alone, may be parked or stored on a residential property in the Village, subject to the following:
- (a) The snowmobiles and such trailer must be in operable condition;
 - (b) There shall be no more than four (4) snowmobiles on one trailer;
 - (c) Between May 1 and October 31 each year, any snowmobiles and/or such trailer shall be parked either inside a garage or off the premises;
 - (d) Between November 1 of one year and April 30 of the next following year, any snowmobiles and/or such trailer may be parked on a driveway or other paved surface on the premises.

I. MOBILE HOMES:

1. No mobile home shall be parked or stored on any property within the Village i) except in an enclosed garage; and ii) except when incidental to construction on or development of a parcel or parcels within the Village on which construction or developer activities are actually taking place, subject to the following:
- a) A mobile home may be used as a temporary office or shelter, but no more than one mobile home shall be allowed on any one property or for any one development;
 - b) Any such mobile home or trailer must be located within the boundaries of the parcel or parcels on which construction or development is actively taking place;
 - c) Any such mobile home or trailer may be located on the premises for a period not in excess of six (6) months, unless a longer period shall be approved by the Corporate Authorities
2. The Chief of Police or his/her designee shall have the ability in his/her sole discretion, to grant, in writing, temporary and limited exceptions to the requirements of this subsection, based on individual requests and circumstances.
