ORDINANCE NO. 2023 - 13

TAX LEVY ORDINANCE

An ordinance levying taxes for all corporate purposes for the VILLAGE OF SLEEPY HOLLOW, KANE COUNTY, ILLINOIS, for the fiscal year commencing on the 1st day of May 2023 and ending on the 30th of April 2024.

BE IT ORDAINED by the President and Board of Trustees of the Village of Sleepy Hollow, Kane County, Illinois:

SECTION 1: That the amounts hereinafter set forth, or so much thereof as may be authorized by law, and the same are hereby levied upon all property subject to taxation within the municipality as that property is assessed and equalized for the current year, and for such purposes as: General Corporate, Police Protection, Parks & Recreation, Street Lighting, General Insurance, Workers Compensation, Audit and Social Security for the fiscal year of the said Village of Sleepy Hollow, Kane County, Illinois, beginning the 1st day of May 2023 and ending on the 30th day of April 2024.

SECTION 2: That the amount levied for each object and purpose is placed in a separate column under the heading "Amount to be Raised by Tax Levy," which appears over same being as follows, to wit:


